5. The members also need to apply for space and deposit their participation charges as and when demanded through the circulars of the respective fair that will be issued by the Council through mail and charges paid now shall be adjusted accordingly.
6. EPCH reserves the right for selection of participants based on the receipt of applications of respective fairs, space availability and other terms as decided by the competent authority.
7. The expression of interest is refundable only if Space is not allotted / participation in fair cancelled or withdrawal by members before allotment of space.
8. The expression of interest and participation charges are non-refundable if :-
 - a). Withdrawal by the applicants after confirmation of participation by the Council.
 - b). MDA Grant is not approved by the Ministry of Commerce for complete event or individually.
 - c). Visa is not granted by the concerned Embassy.
