EXHIBITION SPACE

NORMAL STALL SIZE

12 Sq. Mtr. Or in multiples of 6 Sq. Mtrs.

The organizers reserve the right to reduce or increase the size of the stalls depending on the number of eligible applications and availability of space.

RAW SPACE: For individual booth allotment of 30 Sq. mt. and above. Means only space with one electrical supply point.(Does not include any item given in Modular Stand.)

DETAILS OF MODULAR SHELL STAND

Fully constructed stalls with modular structure shell of 12sq. mt. for the Show will be available for 3 day period with the following furniture, fittings and to be fixtures:

- Three side partition for normal stand
- Floor Carpeting
- Fascia with partition for normal stand
- Electricity point 5/15amp
- One waste paper basket
- Electricity Fittings with 6 spotlights
- One table
- Two chairs

1. **The shelves, showcases and display aids other than the above will be arranged by the participants**
2. **Badges/passes depending on the area allocated to the exhibitors shall be issued free of cost.**
3. **General security for exhibition halls shall also be provided during Exhibition days.**

Eligibility Criteria for Participation

1. The applicant should be member of the Export Promotion Council for Handicrafts.
2. If the total space requirements, as borne out form all the applications received on or before the last date fixed for the purpose is less than or equal to the available space all the applicants will be allotted the space as per their applications.
3. If the total space requirement is more than available for allotment, the organizers will adopt criteria for selection of participants and allotment of space. Their decision shall be binding on all applicants and no review will be made. (Applicants may note, the council can at any time ask them to furnish documents in support of the facts and figures submitted by them).
4. Fair Timing :- 09.00 am to 6.00 pm (24-26 June, 2024)

Participation Charges, Mode and Schedule of Payment.

1. Modular Shell Stand @ ₹ 5,000/- per sq. mtr. + 18% GST (min. 12 sq. mtr.)
2. Raw Space @ ₹ 4,500/- per sq. mtr. + 18% GST (min. 30sq. mtr.)
3. Two side open stand with 10% and additional charges. In case of Clubbed Stand, 10% additional charges will be charged on the gross area.
4. The applicants have to submit their application along with a lump sum amount of Rs. 25,000/- latest by **15th May, 2024** Balance payment immediately on confirmation of stand.

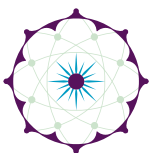

GENERAL EXHIBITOR RULES

1. The Show will be held in the Halls of India Expo Centre & Marts, Greater Noida or as the space available.
2. The Organiser will take preventive course of action for safety, security and fire. However, the organizer shall not be liable for any damage/loss.
3. The organizer reserves the right to change/reschedule the Show or change its venue at any point of time or revise visiting hours for reasons beyond its control. No claim whatsoever shall be entertained from any exhibitor/visitor on this account.
4. The Organiser reserves the right to allot/allocate/reallocate or rejects the application for the space to the applicant.
5. The Organiser reserves the right to cancel the space allotted or deny space to exhibitors already confirmed.
6. The Organiser reserves the right to allocate/reallocate space, charge the layout, add or delete corridors which may affect the orientation of stalls. Its decision in this regards shall be final and binding. The layout of the stands be determined by the organizer and shall be final and binding.
7. Space will be allocated to exhibitors/companies by name of organization and sharing or subletting will not be allowed under any circumstances.
8. If at any stage it is found that any applicant does not fulfill the eligibility criteria or that the applicant has made a false declaration or mis-statement in the application for allotment of space, the Committee reserves the right to cancel the allotment of space at any stage before during the fair.
9. In the event of cancellation of participation by any applicant at any stage, the entire amount deposited till then by the applicant shall stand forfeited.
10. In case space in any stall gets due to pillar or any other obstruction, the Organisers will not be liable for any compensation to the exhibitor except the adjustment of space charges of unutilized space covered by such obstruction.
11. Entry to the Show will be as per the time & schedule as decided by the Organisers. On 26th June, 2024 the Show will close at 6.00 pm.
12. The stalls shall be handed over to the participants, well in time before the scheduled opening. Participants are expected to take away their exhibits immediately after the close of the Show after which the responsibility of the Show organizers shall cease immediately.
13. Modular shell stand structure alongwith the items already mentioned would be provided to the exhibitors. Additional display aids would be arranged by the participants themselves at their own cost. No alterations to the stands shall be permitted.
14. Platforms, podiums etc., leading to exhibits must be constructed within stand area in such a way that they are safe and enable visitors to move freely. No exhibitor or any article would be allowed outside the stall or in the passage area.
15. All passages, emergency exits, main entrance and access to the service area are to be kept clear at all times.
16. Maximum heights of exhibits permitted would be 8ft. from ground level unless permitted by the organizers.
17. Participant's name on Fascia will be provided in standard lettering by the Organiser.
18. In case any exhibitor/visitor having any claim about the design displayed by any exhibitor, he/she should contact the Organiser with documentary evidence i.e. registration of design with Registrar of Copyright/Controller of Patents & Designs, Trade Marks etc. The Organiser on satisfaction can ask the exhibitor for removal of such products from display at the Show.
19. Fire safety rules and regulations will be observed at all time. It is not permitted to store or use inflammable liquids / packaging material or any other such material in the hall.
20. It is not permitted to affix coverings by bonding or to paint hall walls, pillars or any other parts of the hall. Drilling or shooting-in of bolts, as well as hammering of steel nails, dowel, etc. into floor, pillars & panels is not permitted. The cost of damage caused by the exhibitor, its employees, representatives or agents to the exhibits space will be billed to & paid for by the exhibitor before the closing of exhibition.
21. No stand should be left unattended during the exhibition hours. No activity which in the opinion of the Organiser amounts to nuisance or annoyance will be caused by the participants. The playing of music system shall not be allowed. The Organisers shall have the right to take remedial action in such case.
22. All participants are required to remove the night sheets/curtains from their stands prior 15 minutes of the opening of the Show. In defiance of the same, the Organisers reserves the right to have the night sheet/curtains removed or declare the stand officially closed. No claim on account of closure, theft, pilferage etc. will be entertained.
23. In case any exhibitor is found not maintaining proper decorum in the Show, violating health & safety guidelines, distributing literature, bags or any other promotional item, or canvassing in any form in and around the exhibition venue, or not complying with the General Exhibitor Rules, will be served a notice by the Executive Director of the Show to explain their actions. In case this proves unsatisfactory to the Show Organiser, the participation will be asked to either close the stand or will be debarred from future participation in the Organiser's Shows.
24. Entry to the Show by representatives of participants will be on the basis of exhibitor passes issued by the Organiser.
25. Vehicles carrying exhibits etc. can be allowed to come inside the show venue from the designated gates well before the prescribed time of opening of exhibition & 8 hrs after the close of the exhibition with the prior approval of the authorized representative of the Organisers.
26. Exit permit will be required for taking out any material out of exhibition complex during the Show period. Exit permit will be issued by the authorized representative of the Organisers.
27. No exhibits/cases/display material will be allowed to be taken out of exhibition complex after the closing of the Show without exit permit. Exit permit will be issued by the authorized representative of the Organisers upon taking over of the stand from the participant in the same condition.
28. Limited car parking will be allowed within exhibition ground, however cars/vehicle may be parked in the parking areas.
29. Participant will be responsible for the security of their exhibits and stalls. The Organiser will, however, make general security arrangements at the exhibition halls in particular.
30. The Organiser reserves the right to restrain any participants from displaying exhibits which the Organiser finds objectionable.
31. The Organiser reserves the right to photography/video filming any exhibitor for its use without permission of the exhibitors.
32. The Organiser reserves the right of selection, position of advertisements and ending of advertisement material before printing in the Show Directory.
33. For any other disputes, the decision of the Organiser shall be final and binding on the applicant/participant.
34. The Organiser does not take any responsibility for or guarantee the procurement of any business or trade enquiry in the Show.
35. Efforts are being made to target the big domestic volume buyers (no retailers), e-commerce platforms and representatives of overseas buyers via their buying offices based in India.
36. The Organiser will not be responsible for any damage/theft/pilferage/fire in any of the temporary structure due to any acts of God or man.
37. Force Majeure: if the exhibition is abandoned, cancelled or suspended, in whole or in part by reasons of natural calamity, war, fire, national emergency, labour dispute, non-availability of exhibition venue or any of the clause not within the control of the organizer, the organizer may, at their own discretion repay the rental paid by the exhibitor, or part thereof, but shall be under no obligation for any loss of business and pay any compensation.
38. The Courts in Delhi shall have exclusive jurisdiction in all disputes.
39. The participation will be participating in the Show at their own risk and cost.
40. The interpretation of these rules by the Organiser will be final.
41. Retail sale during the Show will not be allowed.
42. Transport of Exhibit's will be done as the E-way bill rules.
43. The interpretation of these rules by the Council will be final.
44. Special instructions to Exhibitors of Raw Space of Own Built Space-Fire Safety Guidelines
 - i. Use of inflammable material like dry grass/straw, jute & synthetic fabric/flex masking will be strictly prohibited.
 - ii. Use of helogen lights or any other high-intensity lights that generate excessive heat will be strictly prohibited.
 - iii. Electrical works in the stands must be entrusted to licensed electrical contractors and use of ISI certified & fire retardant material of approved manufacturers shall be mamdatory.
 - iv. For all raw space stalls, exhibitors are required to install fire setinguishers during the construction & exhibition period including the period of dismantling.
 - v. Incase, the exhibitor's fail to do the same, the Council will install and charges shall be billed to the exhibitor.
