Sub: One Day Training Programme on Goods and Services Tax (GST)-reg (FIRST CUM-FIRST ACCOMMODATED BASIS)

Sir/Madam,

As you are aware, Goods and Services Tax (GST) is one of the biggest taxation reforms in India and is a comprehensive tax levy on manufacture, sale and consumption of goods and services at a National level. GST is all set to integrate the state economies and boost overall Growth.

GST which is to be introduced across the country by 1st July 2017 will affect each and every sector of the economy. In order to educate the exporters about the implication of the GST on handicrafts sector and also how to migrate to the new tax regime, a one day training program for member exporters is being organised.

The day-long event will provide an overview of the GST framework with an emphasis on the provisions relating to transition and compliance. Other important topics proposed to be covered in the sessions will be input tax credit, job work, export/import transactions, input service distributors, filing of returns, etc. Sufficient time is also being provided for the participants to clarify their doubts through the extended Q&A sessions.
