Under GST, member exporters will need to carry an electronic waybill or E Way Billing when moving goods from one place to another. Since it is a new rule introduced under GST, it is necessary for all consignors/consignees/transporters to be aware of the required compliance. The Rules for implementation of nationwide e-way Bill system for inter-State movement of goods on a compulsory basis will be notified with effect from 1st February, 2018. This will bring uniformity across the state for seamless inter-state movement of goods. In this awareness seminar, leading guest faculty will cover the above topic.
