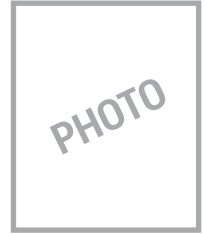

## TERMS AND CONDITIONS OF ADMISSION & PAYMENT OF FEES:

### Please read the conditions carefully

1. To enroll as a Student of EPCH, the application/admission form must be duly filled and signed.
  2. Follow the instructions and terms carefully.
  3. Students are required to submit the following documents
    - a. 1 recent passport size photograph
    - b. Certificate of Birth
    - c. Address Proof
    - d. Identity Proof
    - e. Last school leaving certificate/marksheet
    - f. Last college/university leaving certificate/marksheet (if applicable)
  4. The tuition fees be paid in advance and same is non-refundable and not transferable.
  5. Fee to be paid in favour of EPCH.
  6. The EPCH reserves the right to increase the fees at any time but fee increase will not apply in cases where the fees have already been paid.
  7. In case any student is dismissed or disallowed to attend classes on grounds of indiscipline, then the fee paid shall not be refunded under any circumstances whatsoever.
  8. If any damage is made to the property of EPCH, the student responsible for such damage will have to pay for such damage.
  9. The Cheque dishonor will attract a penalty of Rs. 500.
  10. By enrolling with the EPCH, the students, parents, guardians for the students, consent to the reasonable use of the student's details and academic achievements including images or recordings of the students howsoever made, for promotional purposes.
  11. EPCH shall not be liable either death or personal injury suffered by any student except as may arise through the negligence of the institute. Parents and students also agree that the institute may administer any non prescription medication of first aid as is deemed appropriate and to seek medical, dental or optical treatment when required.
