Specialized trade fairs held in Germany are extensively visited by overseas trade visitors from all important countries of the world for the Gift items covered by the Handicrafts sector. Germany represents tremendous business opportunities for Indian exporters.

Ambiente 2019 starting from **08 – 12 February, 2019 at Messe Frankfurt, Germany** is the consumer-goods event with the widest international product range in Europe. With over 4,800 exhibitors from 94 countries, the Ambiente consumer-goods fair offers an unrivalled overview of the world market in terms of breadth and depth. As the biggest and most international order platform, it attracts around 1,37,000 trade visitors from 152 countries.

PARTICIPATION CHARGES:

1. The participation charge is Rs. 40,250/- per sq. mtr for built-up booth before grant.
2. After MAI Grant to eligible participants, space charges will be subsidised to **Rs. 26,500/-** per sq. mtr including standard built-up booth package in Hall No. 9.2 (Living Section), 9.3 (Living/ Giving Section) & 10.1 (Dining Section). *Please Note: the participation under MAI scheme is given below in note. **Please read carefully** *** P.S.*
3. Two sides open/corner stands will bear additional 10% amount of participation charges @ Rs. 40,250/sqm.
4. The Messe Frankfurt also charges an additional EURO 585 (equal to Rs. 48,000/-) from each participating company towards their Obligatory Media Charges.

The participation charges of the Council are inclusive of space rent, built-up booth, carpet, spot lights, furniture, standard display aids and electricity charges. However, participants have to make their own arrangement & expenses for travel, hotel accommodation, Shipment/Clearing, Customs Duties of exhibits, visa etc. Participant have no right to claim refund if visa not granted. The Council/show organizer reserves the right to selection of participants. The participation guidelines of Messe Frankfurt GmbH for Ambiente shall be applicable. Booth allocation will be based on product profile of the exhibitors and approval by the show organiser.

Interested members are requested to submit their duly filled application form in the prescribed format (enclosed herewith) along with an advance amount of Rs. 1,50,000/- by way of DD/RTGS in favour of the Export Promotion Council for Handicrafts payable at New Delhi latest by 20th September, 2018. The applicants will be informed to deposit the balance participation charges by demand draft/RTGS order only after selection by the Council. In case of withdrawal of participation after the selection by the Council, the application money will be forfeited. GENERAL EXHIBITOR RULES

<u>1.</u>	<p>SPACE BOOKING</p> <ul style="list-style-type: none"> • Participation application should be in prescribed format and be submitted within the prescribed date for booking of space. • Submission of application to EPCH does not automatically confer a right for allotment of space. Approval of application for space will rest with EPCH. • The space allotted to the approved participants is to be exclusively used by them for display of their exhibits as approved by EPCH. Subletting of space is not permissible. Violation of this clause may lead to cancellation of space allotted, forfeiting of space charges, security deposit etc., paid to EPCH and debarring the participation from the future participation in EPCH's event
<u>2.</u>	<p>ALLOTMENT OF SPACE TO THE PARTICIPANTS</p> <ul style="list-style-type: none"> • EPCH reserves the right to select the participants.
<u>3.</u>	<p>WITHDRAWAL & REFUND OF PARTICIPATION FEE</p> <ul style="list-style-type: none"> • Members may please note that after allotment of booth, withdrawal will not be allowed and the amount deposited alongwith application will be forfeited. <p>However, Part-Refund of participation fee will be considered in case where:</p> <ul style="list-style-type: none"> • The participant after approval withdraws from the participation but space is subsequently let out to some other participant who pays for the space. In such cases the first party can be allowed the refund after deducting 10% of the total amount payable. • There is a change in the venue and date of an event, Non-availability of space, rejection of application or in the event of cancellation of participation due to unforeseen circumstances.
<u>4.</u>	<p>VISA</p> <ul style="list-style-type: none"> • The Council will provide necessary assistance by way of issuance of recommendation letter to the concerned Mission for obtaining visas. Visa recommendation letter will be issued only in favour of the Chief Executive / Director / Proprietor/Senior Officer of the company. • Since EPCH, on behalf of the participating company, has already committed for certain financial bindings by booking of space, construction/decoration of stand, catalogue entry, general publicity support etc., it will not be possible to consider any refund on account of denial of visa/delay in receipt of visa.
<u>5.</u>	<p>GENERAL</p> <ul style="list-style-type: none"> • Only goods of Indian origin will be allowed for display at India Pavilion. • In case representative of the participants will not report at booth during the show. EPCH reserve its right to obtain reason from participants for NO SHOW. In case EPCH is not satisfied with clarification of participants EPCH may initiate the necessary action against such participants. • Participants will not be allowed to remove the exhibits during the show without specific written permission from EPCH or show Organisers. • Participants will be required to furnish complete information in EPCH Feedback form about "Business Generated on the spot" "Expected Business to be generated" and also "Number of Enquiries" etc. on the last day of the fair. Compliance with this rule will be one of the criteria for selection of the participants for future of EPCH programmes. • Participants will adhere to such other regulations as may be prescribed by the country in which the show is held and/or the Fair Organisers. • In case of default of any payment due from the participants, EPCH reserves the right to debar them from participation in EPCH's Fair in India & abroad and bring to the notice of appropriate authority. • Participants will make own arrangement for sending their exhibits / handling / clearing of exhibits in India as well as at destination and Council will not have any responsibility towards the same.
