The Council will issue necessary visa recommendation letter in favour of member exporters. Grant of visa is the discretion of concerned Embassy. In case visa is not granted the Council will not be liable and any request for refund of participation charges will not be entertained.

Interested members may please forward their application along with a Demand Draft of **Rs.1,50,000/-** in favour of "**Export Promotion Council for Handicrafts**" payable at New Delhi, or RTGS details mentioned in fact sheet. Balance amount to be deposited on confirmation of participation. The complete application along with requisite amount should reach to the Council's office latest by **24th May, 2019**. If the applicant withdraws their participation after selection, the amount deposited along with application will be forfeited.
