Proposal for Empanelment to provide services of Photography/ Videography/Micro website / Contents Development....

### 1. ELIGIBILITY

- a. The agency should have infrastructure, capability, suitable cameras and manpower to carry out the work of photography & Videography in craft clusters.
- b. The offer should be submitted by reputed agency having at least 2 year experience in undertaking the prescribed jobs and also have relevant job orders in this regard (to be submitted along with their proposal).

- d. The Contents/ Photographs/ Videos taken/ developed/edited by the agency are to be used on micro website, virtual fairs, social media, e-commerce platform and other promotional campaign as required.
- e. The hired photographer has to turn up at the designated place at a short notice, if required (within one day) of the notice/information.
- f. The proof of related experience / job orders copies must be provided with the offer.
- g. EPCH reserves the right not to make payment for photos/videos/content/profiles found to be defective or otherwise considered unsuitable.
