Export Promotion Council for Handicrafts (EPCH) is organising the participation of member handicrafts exporters in 24th edition of China (Sichuan) New Year Festival & Import Commodity Expo 2020 from 14-21 January, 2020 at Convention & Exhibition Center of Century City, Chengdu, China.

The Chinese New Year Shopping festival is being organized since 1997 at Chengdu, China and the 24th edition will be held in January next year and is supported by the Chinese government and organized by Sichuan Marketing Association. It is organized in 9 halls, in an area of 90,000 sq. mtr with around 3000 exhibitors (500 international exhibitors in Hall 2), 300,000 domestic visitors 30,000 Chinese volume buyers (wholesalers).
