Category	Criteria	Renewal Fees
Associate Members	Average annual exports of handicrafts products less than Rs. 10 lakh during the preceding two financial years (i.e., 2024-25 & 2025-26)	Rs. 5,000 + 18% GST = Rs. 5,900/-
Ordinary Members	Average annual exports of handicrafts products of Rs. 10 lakh and above during the preceding two financial years	Rs. 7,500 + 18% GST = Rs. 8,850/-
