With topics like Export Marketing of Handicrafts; Incentives & Benefits, Export Promotion Schemes of Gol and DC(H); Compliance; Foreign Currency Hedging and Credit Guarantee; Packaging and Bar Coding; Brand Building, Design Protection and understanding New Intellectual Property Challenges; E-Commerce Led Exports, etc. the seminars are addressed by experts from various fields and interacting with the participants to sort out their doubts as well as queries. Starting from 12th November, 2013, a total of 22seminars were conducted during November and December 2013. In January 2014 -- seminars were organized. ### Kolkata, West Bengal

**4th January, 2014** Awareness Seminar on International Commercial Terms(INCOTERMS) & Risks of Foreign Trade

Mr. O P Prahladka, Convenor, Eastern Region-EPCH, chaired this seminar, that had among speakers, Mr. R N Bose, Guest Lecturer, Indian Institute of Foreign Trade and Mr. R N Mishra, eminent Forex Advisor.

The objective was to address major difficulties one faces either as a manager or an entrepreneur with respect to identifying risk related to foreign market, product development, payment & financing procedures and documentation as well as issues related to INCOTERMS and minimizing risks of foreign trade in world market.

### **11th January, 2014** Understanding Impact of CIBIL Reports and Credit Training for Small & Medium Exporters

Mr. Nirmal Kanti Sengupta, Ex-Banker, SBI and Mr R. N. Mishra, eminent Forex advisor presided over as leading speakers on the subject. The objective of the seminar was to understand the concept of pre-shipment finance and familiarization with the procedural aspects of sanction, disbursal and other aspects of packing credit, etc. including the concept, advantages / disadvantages, credit rating indicators as well as terminology.

During interactions, Mr. Sengupta discussed aspects like, disbursement, liquidation of packing credit, Post Shipment Finance for exporters and suppliers. He briefed the participants on export bills, Exchange Earner's Foreign Currency Account (EEFC) and Sanction of Pre-Shipment finance in foreign currency, Choice of currency – decision parameters, etc.

Mr R N Mishra, explained the benefits for lenders and SMEs as the rapid growth of the SME sector creates exciting lending opportunities for banks and financial institutions. He further informed the participants that SMEs can leverage their ratings for negotiating better borrowing rates and strengthening their relationships with bankers.

#### 18th January, 2014

Seminar on Understanding the Procedures of Custom Clearance of Export & Import Cargo, Wild Life Pre-Shipment Inspection and Drawback Claims

Custom clearance is a complex and time taking procedure that every exporter faces in his export business. The objective of this seminar was to append a revised and amended awareness of the custom rules and regulations on Custom procedure; Clearance of goods from ports; Baggage provisions; Goods imported and exported by post; Store; Goods in transits; and Duty drawback provisions, etc. This was elaborated by Mr. H D Majumder, lecturer from National Academy of Customs Excise & Narcotics.

Mr. Sandip Routh, Appraiser, Indian Customs, NSCBI Airport, Govt. of India and Mr. Animesh Mukherjee, Foreign Trade Consultant, explained about duty drawback provisions. Mr. C Behera, Regional Dy. Director, ER, Wildlife Crime Control Bureau, explained the functions of Wildlife Crime Control Bureau and their significance in foreign trade. It was an eye opener for many of the participants about duty drawback aspects.

#### 25th January, 2014

With Mr. S S Gupta, Development Commissioner (Handicrafts) as the Chief Guest, this seminar had experts like Dr. Tamanna Chaturvedi, Assistant Professor at Indian Institute of Foreign Trade (IIFT), New Delhi and Mr. Dhruv Sahai, Senior Expert (Compliance) of M/s Sentio Advisory, interact with the participants. While Dr. Chaturvedi informed of necessary compliances, Mr. Dhuruv Sahai, who has edited and compiled the Guidance Handbook, informed the participants about the contents of the book and its relevance in guiding handicraft manufacturers achieve higher social compliance and labour standards. Both made a detailed presentation on health and safety measures and other important compliances required by the handicrafts sector and urged the member exporters to get their factories compliant with the international norms.

Speaking on the occasion, Mr. Rakesh Kumar, Executive Director, EPCH, stressed on the significance of following international compliances in order to sustain export business.

The highlight of this seminar was release of the "Guidance Handbook for the Handicrafts Exporters of India - Socio Legal Standards" in 11 regional languages. Mr. S S Gupta expressed satisfaction over the deliberations at the seminar and hoped that with the compliance measures and safeguards available in the country, prospects of increased exports in the future look promising. However, the message of compliance is required to be percolated to every corner of the country.

#### 25th January, 2014

Awareness Seminar on Importance of Packaging & Bar Coding in Exports of Handicrafts



At this seminar, Mr. Gopal Valecha of Bar Coding India Ltd. informed participants about the importance of Barcoding as an IT tool for automatic data capture.

Mr. L M Gupta, Director, Package Design Research & Test Lab, interacted with the participants and highlighted the inter relation of exporting handicrafts and packaging, in context of safety of the product. He informed that packaging is one of the crucial aspects of exports as it not only protects products from being damaged, but is also required for regulatory compliance whereas, barcoding which is an integral part of automation requires minimal manual interaction with its associated benefits in reducing handling costs, activity times, lowering logistics costs and increasing accuracy/speed in managing various day-to-day business operations. These two aspects are key to success in today's business.

### Moradabad, U.P.

**9th January, 2014** Seminar on Quality Control and Export Inspection

At this seminar, Mrs. Vaishali Dhingra, Associate Professor, Teerthanker Mahaveer University, Moradabad, and Dr. Ravinder Kumar Sharma, Head of Laboratory, Metal Handicraft Service Centre, Moradabad, made detailed presentations on Quality Control & Export Inspection.

Mrs Dhingra spoke on the basic operating characteristics of a product and said that the little "q" approach-old thinking about quality is changing and that quality is about organization, it is strategic and for everyone and not just for quality inspectors. It is led by management and leads to improvement.

Dr. Ravinder Kumar Sharma informed the participants about the features that make quality control & export inspection effective. Informing about selection of raw material, he said that material must be radioactive contamination free & defined by buyer based on uses of the handicrafts product / need of customer / quality parameters & country regulations.

The objective of the seminar was to provide the required knowledge on the features of quality, performance, reliability, conformance, durability, serviceability, aesthetics, safety & preceptions.

#### **16th January, 2014** Seminar on Custom Clearance of Export & Import Cargo

This seminar custom clearance was aimed to educate the participants about various types of shipping bills used by exporters as well as various types of bills of entry filled by importers.

Over 35 member exporters and buying agents actively participated. Among key presenters were, Mr. D D Mangal, Assistant Commissioner, Customs (Moradabad Customs Dept.); Mr. Arvind Vadhera, COA Member, EPCH; and Mr. R N Katyal, President, CHA Association.

Mr. R N Katyal explained the procedure involved in getting import & export cargo cleared, in order to apprise the participants about each step-from filling of shipping bill / bill of entry to let export order or out of charge order by customs. He also informed the participants about the Customs Traffic Act, various circulars & notifications and their implications on exports & imports. He further informed the participants about various Government incentives / benefits that are available to the exporters and how these can be availed by them.

Mr. R N Katyal also stressed on the need of proper & correct filling of shipping bills in order to claim various benefits and also to facilitate smoother and faster clearance of goods at the customs. He further informed about the EDI system, ICE: Gate, Role of Customs for Export Clearance, Examination by Customs, Final Print, RMS, etc. Participants were urged to make use of EDI-the computer to computer transfer of commercial and administrative transactions using an agreed standard structure pertaining to transaction.

The participants also learnt about RMS, i.e. Risk Management System that has been introduced for faster clearance, lower transaction cost, high service standards as well as direct delivery of cargo. Among benefits of RMS, participants were encouraged towards voluntary compliance as well.
