#### 27th December, 2014; New Delhi

Presided over by Mr. Ravi K Passi, COA Member, EPCH, this seminar saw over 30 delegates and guest speaker, Prof. Ashok Advani from Jaipuria Institute of Management. Prof. Advani shared about the origin of this system, when the challenge was to design a shipping container that could efficiently be loaded onto ships and would hold securely on long sea voyages. Prof. Advani touched upon the important terminologies related to the shipping industry. Speaking about container types, he mentioned of dimensions and capacities, necessity of container leasing and keeping an inventory on leasing. There are many types of containers such as Dry Storage Container, Flat Rack Container, Open Top Container, Reefer Container,

GOH (Garment on Hanger) Containers, Insulated or Thermal Container, Tank Container, Car Carrier, Special Purpose Container, Swap Bodies, Half Height Containers, etc. Major companies that operate container leasing

services are Triton, Geseaco, Cronos, Textainer(Gateway), Gold Container, Bridgehead, Transamerica, Capital Lease and Florens. Prof. Advani also discussed about important factors affecting freight, freight structure and components as well as demurrage charges, that are levied on cargo in containers overstaying at the terminal and charged by the shipping line beyond standard free time allowed by them which is applicable both in the import & export cycles. ■

## Duty Drawback-policy & procedure 10th January, 2015; New Delhi

Mr. Malhotra, COA Member and Ex-Chairman, EPCH chaired the seminar on Duty Drawback-policy & procedure, that saw the presence of around 60 exporters. Guest speaker, Dr. Ram Singh, Associate Professor, International Trade Operations and Logistics, IIFT, New Delhi, initiated his presentation with a brief on drawback and explained goods' eligibility criteria for drawback, types of drawback, duties rebated under the

scheme, drawback on re-export of used goods, elements necessary to claim drawback, etc.

Dr. Singh explained that Duty Drawback - one of the popular and principal methods of encouraging exports, is a method of refund of custom duties paid on the inputs or raw materials and service tax paid on the input services used in the manufacture of export goods. Drawback provisions are given under section 74 and 75 of the custom Act, 1962. Section 74 allows duty drawback on the re-export of duty paid goods. Whereas Section 75 allows the drawback on imported goods used in the manufacture of export goods.

In case of such goods which were earlier imported on payment of duty and are later exported within a specified period, Customs duty paid at the time of import of the goods, with certain cuts, can be claimed as Duty Drawback at the time of export of such goods. Where the goods are not put into use after import, 98% of Duty Drawback is admissible under Section 74 of the Customs Act, 1962. No Duty Drawback is available if the goods are exported 18 months after import. Application for Duty Drawback is required to be made within 3 months from the date of export of goods.

This seminar was aimed at the importance of packaging and bar coding in the handicraft exports sector and also on skill development which is channeled through a separate body known as the Handicrafts and Carpets Sector Skill Council (HCSSC).

EPCH COA Members, Mr. Raj Kumar Malhotra and Mr. Ravi K Passi presided over the seminar and moderated the event, adding valuable insights in course of the interactions. They spoke on the current exports scenario and how barcoding and packaging can drastically change an exporter's performance. Packaging is the key to creating a presentation appeal for the export goods and barcoding is the newly emerging international standard that gives all product related information at every point of inspection.

Mr. Madhab Chakraborty from The Indian Institute of Packaging (IIP), gave valuable insights on how different clusters have been performing. He spoke on the challenges and present state scenario of skill levels present in the handicrafts cluster and the need to reach further clusters. He also touched upon the need to keep alive, handcrafting skills that forms the industry's backbone and workforce shortage may affect this. Hence, skills need to be honed. He also spoke on the importance of packaging and its benefits in terms of visual appeal and aesthetic qualities. Mr. Manish Singh who represents HCSSC, spoke on the growing importance of skilling and its impact thereof, reiterating the fact that skilled labour would create the next-wave quality workforce that the industry can rely on and ensure that this niche space continues to produce unique and artistic handmade products. NOS or National Occupational standards and Quality frameworks are being developed and tested with the help of various skill centres and training and skilling partners.
