He also referred to various marketing channels for exporting handicrafts from India and also urged member exporters to utilize the same. He also requested the participants to visit websites of DGFT and Ministry of Commerce & Industry, Govt of India, on regular basis to stay updated on incentives/schemes of Govt of India.

Mr.Chakraborty interacted individually with the participating artisans from Domjur, Amata, Bargachia, Jagdishpur, Khanpara and Howrah, producing various handicraft products such as artificial jewellery, zari embroidery, metal crafts, wood crafts, horn, bone & shell craft, terracotta and jute crafts, etc. He also advised artisans to get in touch with him in case of any problem in getting IEC Code, getting incentives and in import of raw materials for handicraft production, etc.

# Safeguard business from Cyber Crime during Online Transactions

A variety of internet scams, many based on phishing and social engineering, target consumers and businesses. Mr. Kumar pointed out ways to be adopted as safeguard from online crimes, like use original antivirus software; refusing social media invitations from people you don't know, changing passwords to e-mail, etc., separate account for bank and financial accounts, etc. He also answered gueries.

# "VRIKSH"-Indian Timber Legality Assessment and Verification Scheme

#### Saharanpur; 11<sup>th</sup> August, 2015

The seminar was presided over by Sheikh Faizan Ahmed, leading handicrafts exporter from Saharanpur and ex-COA Member, EPCH. The session was conducted by Ms. Kamakshi Kalia from SCS Global, Greater Noida. She discussed about the importance of using legally procured timber for exports to European countries. The procurement and use of legal sources of wood for the manufacturing of handicrafts and to match international manufacturing standards has been a major issue

raised by buyers and other stakeholders involved in the sector. Keeping this in view the Council has initiated a scheme named "VRIKSH"- Indian Timber Legality Assessment and Verification Scheme, the Due Diligence Scheme, prepared for member exporters as per the demand of overseas buyers. VRIKSH certification is a standard norm which has been designed to allow companies to avoid trading in illegally harvested wood. Compliance with the standard allow companies to demonstrate that they are implementing best efforts to avoid the trade in illegally harvested timber, in support of the international FLEGT program, the EUTR, the US Lacey Act amendment 2008, The Illegal logging Prohibition act 2012 and other such global timber legality verification programs.

#### Export Marketing, Procedure, Documentation, Export Packaging, Online Marketing and e-Commerce Gauripur (Assam); 11<sup>th</sup> & 12<sup>th</sup> August, 2015

The seminar was aimed to educate the crafts persons, artians, national awardees, NGOs/SHGs, entrepreneurs and manufacturers in the handicraft cluster of Gauripur (Assam), a craft cluster that is known for terracotta, jute and bamboo crafts. The guest speakers shared their views on status and uniqueness of the regional handicrafts that involved not only natural raw materials but also eco-friendly processes and could be tuned for exports. While terracotta products have a good domestic market, cane and bamboo crafts are yet to find demand in markets outside the state. On day one, Mr. B Mili
