In terms of Articles of Association of EPCH and Election Rules, the Committee of Administration has appointed the undersigned as the "Returning Officer" for holding the Election of the Members of Committee of Administration of EPCH. The nominations (Form-II) will be received as per the enclosed Notice of Schedule for Election (Form-I) in the Council's office at EPCH House, Pocket 6 & 7, Sector – C, LSC, Vasant Kunj, New Delhi – 110 070.
